Placement on the Administrative Salary Schedule will be at the appropriate step or at the step immediately above where the administrator was placed on the teacher's salary schedule, whichever is higher.

In addition to the salary set forth, effective the beginning of the 2016-2017 school year all administrators who have earned additional educational increments above the Master's Degree will be compensated as follows:

Master's + 15 Credits:	2.0% of Step 2 of COLUMN D	\$1,372.77
Master's + 30 Credits:	3.5% of Step 2 of COLUMN D	\$2,402.32
Master's + 45 Credits:	5.0% of Step 2 of COLUMN D	\$3,431.91
Master's + 60 Credits or Ph.D.:	6.5% of Step 2 of COLUMN D	\$4,461.47

Credits earned after August 31st of any year will apply toward placement on the salary schedule for the following year.

The Carson City School District pays 100% of the contribution to the Public Employees Retirement System for retirement benefits for each employee. In addition, the school district pays for insurance as stipulated in the negotiated agreement.
